Minutes of Coombe Bissett Ordinary Parish Council Meeting held at Coombe Bissett Village Hall on Tuesday 14th November 2023. The meeting started at 7pm.

Public Session

PC Murphy submitted a report:

- On 20th October there was a suspicious incident on HOMINGTON ROAD whereby an unknown male approached the post office store in the early hours of the morning, however when more staff were present the male suddenly then left the area at speed. It is suspected that the male was scoping out the area however was then put off and left. There have been no further reports since.
- On 7th November there was a report in the village that a motorcyclist failed to give way to an oncoming vehicle and as a result fell off into a ditch. No one was injured, Police or Ambulance Service were not called.

Mrs E Haworth, Headteacher Coombe Bissett Primary School.

Mrs Haworth introduced herself and expressed her intentions to make the School part of the Community. They are happy to help and be involved with any events in the villages. They have started a few community events:

1st Friday of every month a coffee morning is held.

3rd Friday of every month a parent and toddler event is held.

24th November 2023 a planting event at the School is open to all residents, the School welcome all residents to help with planting of shrubs.

Mr D Rattue, Shutts Lane Lighting.

Mr Rattue asked why the Parish Council had decided to remove the three streetlights on Shutts Lane. A resolution to remove the lighting at the July and September 2023 meetings was made based on a number of reasons:

A resident had asked the parish council to remove the streetlights. Two of the lights have not worked for months, or years, and no-one had commented, or reported it to Wiltshire Council, as far as the parish council is aware. Approximately 0.2% of parishioners (15 votes in total) responded to the public consultation held during summer 2023, with nearly equal votes for retention and removal. Due to the lack of responses from the recent survey carried out by the Parish Council, it was decided residents did not feel strongly enough about the lights to justify the cost of replacing the lights, and the annual electricity cost for running them. Shutts Lane is within the Dark Skies Area of Cranborne Chase Area of Outstanding Natural Beauty. Coombe Bissett Village Hall Committee was asked if they would like to take on the responsibility of the light in the village hall car park, they declined. However, they are planning to fit further, more suitable lighting around the Hall. As a result, the parish council had voted for their removal. It was agreed that the one remaining light will not be removed until it has stopped working.

Mr B Brealey, Ultra-Fast Broadband.

Cllr Richard Clewer has no further update as it is currently on hold. Once he receives further information, he will update the Council.

The Parish Council will monitor this and await further information.

Mrs White, Speed Indicator Advice.

An email was sent by Mrs White advising that the post for the SID is in the wrong position. The Parish Council is aware of this, following changes to guidance, and has been trying to get Wiltshire Council to move the post. A Parish Councillor is hoping to meet with a Wiltshire Council engineer later in the week to confirm the correct position of the post.

Mr R Maycock

Mr Maycock has requested the grips below Foundry Cottage and on Drove Lane be cleared. This will be submitted for the next Parish Steward visit.

83.23 Draft Budget. To consider and approve the draft Budget for financial year 2024/25. **Resolved:** The adoption of the FY2024/25 Parish Council Budget was considered and agreed by all Cllrs.

84.23 Precept. To consider and approve the Precept for financial year 2024/25. The Council noted that due to the high level of inflation over the past 18 months the current £12,000 Precept no longer covered the Council's operating costs and did not fund asset maintenance or new projects. **Resolved:** Following the adoption of the FY 2024/25 Parish Council Budget, an increase in Precept to £13,000, which is equivalent to an increase of 4% over each of the last two years, was proposed by Cllr Hobson, seconded by Cllr Byatt and unanimously agreed.

85.23 Gabion bags in River Ebble Opposite Fox & Goose. To consider asking Wiltshire Council's Enforcement Department for advice and to take any necessary action if required. **Resolved:** All Cllrs agreed to ask Wiltshire Council's Enforcement Team to investigate the structure and consider taking action to remove the gabion bags if not compliant.

86.23 Pennings Drove Cemetery.

a) To consider installing a water supply to the Cemetery. **Resolved:** The Tennis Club has agreed to have two water butts running from the Clubhouse which will be for cemetery use.
b) To consider the repairs required to the gate. A request to remove the gates so they may be repaired and painted by a volunteer in dry conditions. **Resolved:** All Cllrs agreed to this.

c) To consider and adopt the Memorial Safety Policy. **Resolved:** Cllrs considered and agreed to adopt the Policy.

87.23 Village Parking. Cllr Bird recently met with the Village Parking Committee to review any further issues. Improvements have been made and use of the field by the school has helped with parking. It was agreed the Clerk would send out the Parking Policy with any parking requests for the recreation field.

88.23 Ultrafast Broadband. The CB&H project team request that the Parish Council seeks to establish whether CB&H have been included in the Lot 30 contract. *See public session.*

89.23 Clerk's Report/Items carried forward from previous meeting:

a) Playpark. Works still to be completed: Waiting for an update.

Litter Bin: to be secured.

Corrosion: on the combination goal.

Paintwork: Some areas are in poor condition and need repainting.

Swing: shackles need oiling. *These have now been oiled.*

Resolved: As no volunteer has offered to do the work, it was agreed to commission a contractor to carry out the repairs.

RoSPA Annual inspection was carried out in Sept which highlighted the above works. Cllr Bird gave a brief explanation of the report. Some of the items highlighted are the works still to be completed, the 'warning' sign needs to be repaired which Cllr Bird will repair.

b) Parish Steward. Visit scheduled for 23rd November 2023. *Worksheet submitted by Clerk.*

90.23 Highways.

a) Fox & Goose. Lying water continues to damage the splash onto the property cause damage. Works are scheduled to start at the end of October 2023. *The Clerk has followed this up and still waiting for a reply.*

a) Flood Plan. To consider and adopt. **Resolved:** Cllr King volunteered to be the new Flood Warden for Homington. Cllrs thanked Cllr King and agreed to adopt the Flood.

b) Snow plan. To review and agree the updated plan. **Resolved:** Cllr Boxall volunteered to be the Snow Warden for Homington. Cllrs thanked Cllr Boxall; the updated plan was adopted.

c) Following the continuous flooding on Homington Road a request to Wiltshire Council to inspect and repair the drains under the road will be submitted. Mr D Parson has kindly offered to sharing all the information he has to assist with this request.
